

County Health Officer Confirms Tasting Rooms Can Reopen Without Previously Mandated Food Service Requirement, as of June 12

SVVGA has received confirmation from the Sonoma County Board of Supervisors and Sonoma County Health Officer Dr. Sundari Mase that effective as of 12:01 AM this Friday, June 12, Sonoma County winery tasting rooms CAN re-open WITHOUT the previously mandated food service requirement. This aligns with the state guidance released on Friday, June 5.

The California Department of Public Health, last week, released new guidance on how local jurisdictions should modify behavior and operations to reduce risk for infection. All wineries must continue to follow and comply with all COVID-19 mitigation practices and social distancing protocols for their respective facilities as outlined in the June 5 California Department of Public Health (CDPH) Guidance for 'restaurants, bars, and wineries.'
